A16: During the summer months we are instituting Eagle Flight School where we are extending our learning experiences for our students indoor/outdoor because of the learning disruption and loss of instructional time due to the pandemic. In order to address the social and emotional needs of our students, we will have Social Workers working with students, teachers, and parents throughout the summer. B1: In order to address the learning loss of our students, we will be administering and using high quality assessments to gauge our student progress. We are going to employ a Secondary New Teacher Instructional Coach, Instructional Coaches, and Deans (Academics/Students) who will be ensuring that the assessments are administered and used as a tool to help our students grow and make progress. B2: In order to address the learning loss of our students and enrich their experiences in the summers, we are paying: Curriculum Writers, Instructional Coaches, Master Planners, Interventionists, Teachers, and Aides to assist in the process of developing evidence-based activities to meet the extensive needs of our students. In addition to developing the activities, they will be organizing materials and ensuring that we have a strong viable curriculum for our summer programs. Additionally, we will be ensuring this extends into the school year by incentivizing our returning staff who has aided in the development of processes to address learning loss of our students during the pandemic.
